

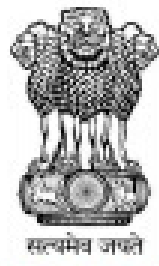

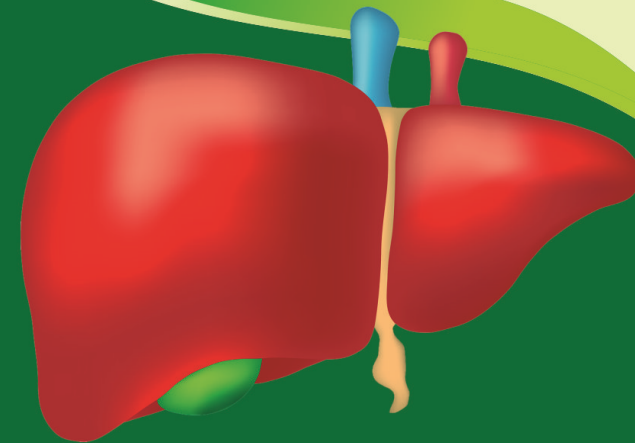

HOW TO ACHIEVE INCENTIVES

Distribution Method of Incentives to Direct Seller:

1 BSP = 10 Rs.
